#### Healthy New York Individual/Sole Proprietor Rate Schedule

Monthly Rate for New York residents residing in the following counties: Bronx, Dutchess, Kings, Nassau, New York, Orange, Putnam, Queens, Richmond, Rockland, Suffolk, Westchester, Sullivan, Ulster.

The monthly rate will depend on the month coverage begins. If we receive properly completed forms between the 1st and 20th of the month, coverage will be effective the 1st of the following month. If we receive properly completed forms between the 21st and 31st of the month, coverage will be effective the 1st of the month following 30 days.

#### Rates shown include the following:

Assumed Dependent Eligibility — A dependent child is eligible until he/she reaches the age of 26. A sole proprietor or subscriber may elect to cover the dependent child(ren) until the end of the month he/she turns 30. If elected, coverage for dependents to age 30 can be provided for an additional premium.

These quoted monthly rates are valid only for the conditions stated above and such other terms and conditions as are set forth in the Aetna contract or official renewal letter.
