H0015	905 or 906	Alcohol and/or drug services; intensive outpatient (treatment program that operates at least 3 hours/day and at least 3 days/week and is based on an individualized treatment plan), including assessment, counseling; crisis intervention, and activity therapies or education
H2012	912 or 913 (if contracted for this code)	Behavioral health day treatment, per hour
S9480	905 or 906	Intensive outpatient psychiatric services, per diem

Service Code	Revenue Code	Service Description
H0035	912 or 913	Mental health partial hospitalization, treatment, less than 24 hours
H2036	912 or 913	Alcohol and/or other drug treatment program, per diem

## ABA: televideo only

Code	Service Description
97151	Behavior identification assessment, administered by a QHP, face-to-face with patient and/or guardians administering assessments and discussing findings and recommendations. Includes non-face-to-face analyzing of past data, scoring/interpreting the assessment, and preparing the report/treatment plan
97153	Adaptive behavior treatment by protocol, administered by technician under the direction of a physician or other qualified healthcare professional, face-to-face with one patient, each 15 minutes

### ABA: televideo only

Code	Service Description
97155	Adaptive behavior treatment with protocol modification, administered by QHP, which may include simultaneous direction of a technician working face-to-face with a patient
97156	Family adaptive behavior treatment guidance administered by QHP, with parent/guardian
97157	Multiple-family group adaptive behavior treatment guidance, administered by QHP, with multiple sets of parents/guardians

G2086	Office-based treatment for opioid use disorder, including development of the treatment plan, care coordination, individual therapy and group therapy and counseling; at least 70 minutes in the first calendar month
G2087	Office-based treatment for opioid use disorder, including care coordination, individual therapy and group therapy and counseling; at least 60 minutes in a subsequent calendar month
G2088	Office-based treatment for opioid use disorder, including care coordination, individual therapy and group therapy and counseling; each additional 30 minutes beyond the first 120 minutes

### Pharmacologic management: televideo and audio

G0459	Inpatient telehealth pharmacologic management, including prescription, use, and review of medication with no more than minimal psychotherapy

96121	Neurobehavioral status examination: clinical assessment of thinking, reasoning, and judgment, by physician or other QHP, both face-to-face time with the patient and time interpreting test results and preparing report; each additional hour (list separately in addition to code for primary procedure)
96130	Psychological testing evaluation services by physician or other qualified health care professional, including integration of patient data, interpretation of standardized test results and clinical data, clinical decision making, treatment planning and report and interactive feedback to the patient, family member(s) or caregiver(s), when performed; first hour
96131	Each additional hour
